The Global Partnership for Sustainable Transport

Transportation affects all aspects of our lives. Mobility is a fundamental human need, and technological innovation in the transportation sector in the last century has brought the world closer and enabled an unprecedented form of human connectivity. Yet, with rapid urbanization and increasing gap of inequality, a significant proportion of the world population does not enjoy the full benefit of the transportation system and services. Transportation is an engine for economic growth and defines contemporary life styles, directly employing millions of people and accounting for a substantial percentage of the gross domestic product in many parts of the world. Our global economic system and trade mechanisms rely on robust transportation ecosystem.

The essential role of transport in driving economic growth is, however, undermined by the sector's negative footprint on environmental, social and governance (ESG) issues throughout the global supply chain. In particular, poorly-maintained and outdated transport equipment result in pollution and poses a danger to human health. Inadequate transport planning, enforcement and supportive policy actions create a void in which the safety of operators, passengers and users of transport and pedestrians and members of local communities is compromised through exposure to accidents and other hazardous conditions. Finally, actions are needed to ensure cooperation at all levels – local, national, regional and global to ensure sound governance structures that promote compliance, efficiency and that ultimately increase the competitiveness of the transport sector in order to better serve larger societal goals of facilitating movement, transit and access to goods and opportunities.

For sustainable development to deliver its aspiration, ESG issues must therefore be integrated into all aspects of the transportation debates.

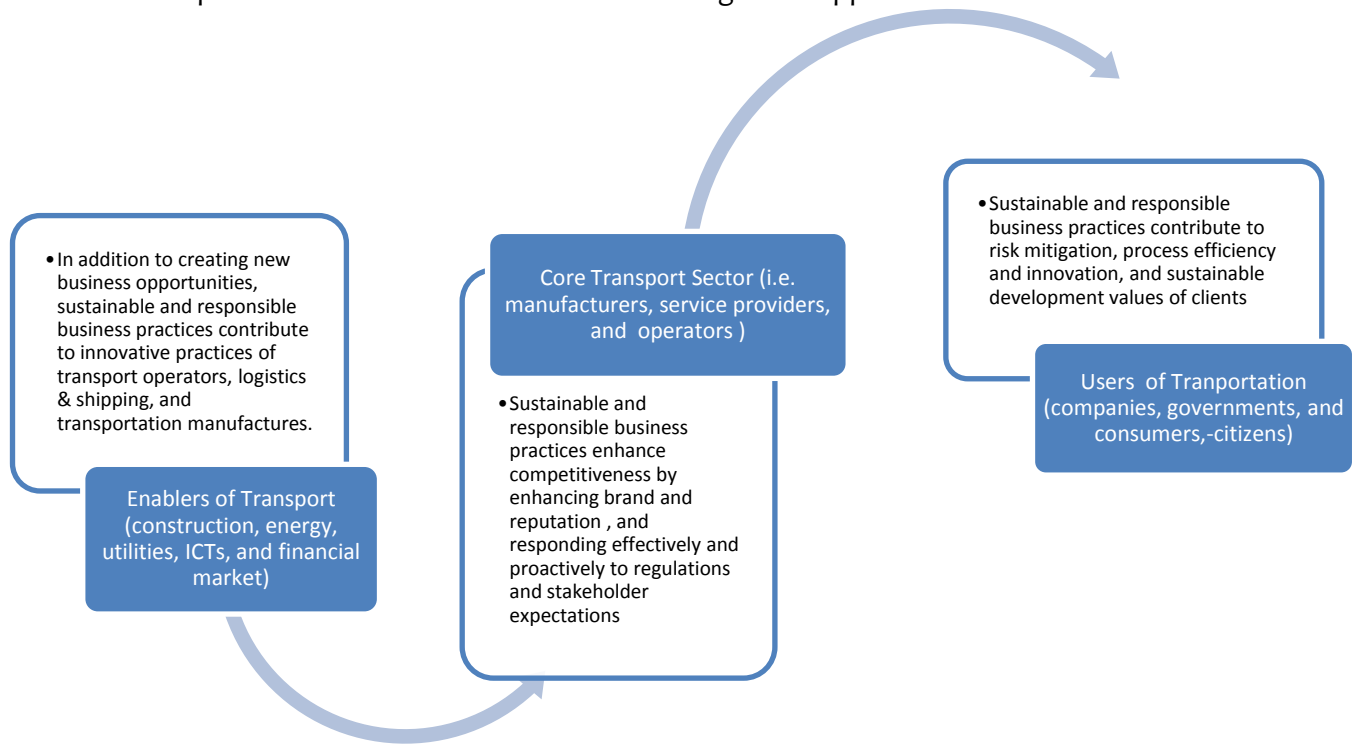
As a business and industry-led initiative, the Global Partnership for Sustainable Transport (GPST) focuses on a range of key material topics in the transportation sector with a view to enhancing the industry's positive footprint on ESG priorities. By bringing companies and industry associations from all modes of transportation together with other stakeholders, the GPST fosters collective action and sustainability collaboration in support of the vision of the 2030 Agenda for Sustainable Development and the recommendations of the UN Secretary-General's High-Level Advisory Group on Sustainable Development. In addition to supporting existing transportation sector partnerships, the initiative mobilizes business and industry associations to advocate the effective integration of ESG issues into macro topics such as trade facilitation and transit corridor development.
